A statement on shared decision-making and holistic assessment addresses safety concerns. Toric Intraocular Lenses: The DDICB commissioning position has been clarified following multiple Individual Funding Requests Toric Intraocular Lenses for astigmatism correction in patients undergoing cataract surgery is not normally funded by ICBs. This is due to a lack of quality evidence regarding the long term clinical effectiveness of this procedure.
